On July 6, 1966 Mike O'Connor enlisted into the Army Warrant Officer Flight Training Program. A year later, after completing flight training and advanced missile training, he was assigned to an Aerial Rocket Artillery unit (C Battery, 2<sup>nd</sup> Battalion, 20<sup>th</sup> Regiment, 3<sup>rd</sup> Brigade) of the 1<sup>st</sup> Air Cavalry Division. After extensive combat throughout I Corp, Mike's unit, was moved North of Hue (pronounced 'way') in the midst of the 1968 Tet Offensive.

Mike's aircraft was shot down in the early morning on February 4, 1968; in support of U.S. troops who were 'pinned down' just north of Hue. He was the only survivor from his crew of four. His Aircraft Commander Ron Fields, Door Gunner Sgt. Adler, and Crew Chief Sgt. Reeves, were all killed by gun fire and in the crash. Mike was shot in his left shoulder and sustained numerous

injuries from the crash. Despite his injuries he evaded the enemy for a day and half before being captured the following evening.



Over the next several months Mike, along with other U.S. military and civilian personnel were moved from various camps in the mountains of South Vietnam and Laos into North Vietnam. Conditions were extremely difficult. Four South Vietnamese Rangers who were captured with Mike were taken from his holding area and presumed executed, and an American civilian sitting next to him in the jungle was killed by interdiction bombing. Mike was poisoned by one of the guards and subsequently developed such severe food poisoning that he was going to be left behind and presumably executed by the guards. It was only due to the heroic and adamant protest of the other surviving Americans that he survived.

After more than five years in various prison camps; Mike was finally released on March 5th, 1973 under the conditions of the Peace Agreement. For his service, he was award numerous medals; including the Silver Star, Bronze Star, Distinguished Flying Cross, Air Medal with 'V' device for Valor, Three Purple Hearts, and the POW Medal.

Unable to return to military flight duty due to his injuries upon his return; Mike pursued a career as a Branch Chief in Personnel with the Air Force at McClellan AFB; and later as the Assistant Personnel Director with the County of Yuba. Mike has been married to his wife Dawn for over 31 years and they have two sons, Chris and Andy, who both recently graduated from college. Mike and his wife reside just outside of Lincoln, CA.




### The Swamp Fox


