I recently was saddened to learn of the passing of former compatriot William C. "Kelly" Rightmer. Unfortunately, I didn't personally know Kelly, but in my previous role as chapter secretary, I processed the documents to the NSSAR to enroll him in the California Company of World War II veterans. He was awarded the NSSAR Certificate of Patriotism in 2012 for his service. As a young Marine PFC, Kelly was in the first landing wave at Tarawa Atoll in the Gilbert Islands, on November 20th, 1943. Kelly was wounded during the battle and was discharged in 1944.

I would like to remind the membership that the National History Day-California competition is going to be held at William Jessup University in Rocklin on May 8th and 9th. Past President Russ Kaiser presented Jeff Goodwin and Neil Zinn Certificates of Appreciation for helping the Chapter during the 2014 year.

President Craig Anderson announced that we need volunteers to attend the National History Day – a California competition to be held at William Jessup University in Rocklin on May 8th and 9th. President Anderson has volunteered to help judge the event but more volunteers are needed and he invited members to join him. Anyone interested in participating was asked to contact President Anderson after the meeting for more information.

President Anderson asked Alan Brooking and new member Samuel Smith Senior Master Sgt Ethan Cao. Past President and Color Guard Commander Russ Kaiser explained that that his duties involve the traditional Color Guard and also the School Guard. doing. There are two presentations on March 23 and one on March 26. President Anderson encouraged members to support this group.

Dinner was served.

After dinner President Anderson introduced Sacramento Chapter member Ted Robinson who is best known as the naval officer who rescued future president John F. Kennedy from PT 109 in the Pacific during World War II. Lt. Commander Robinson shared his experience with the Battle of Okinawa. He told a heartwarming story of one sailor under his command, Seaman Kelly. Before entering the navy Seaman Kelly was headed for trouble but through the efforts of his, "adopted mother" (the mother of his best friend) he joined the Navy. After struggling to find the right path he was made Coxswain of an LCVP that was a working boat of the ship LST 1062. Lt Commander Robinson shared how they were attempting to rescue 100 soldiers in extremely bad weather from behind enemy lines. The LST was being pushed in the wrong direction and onto rocks. Seaman Kelly used his LCVP to push the ship out of danger and saved the ship and solders from the Japanese. It was thought Seaman Kelly had died but he was able to make his way back to the ship. Lt Commander Robinson promoted him two ranks to Boatswain's Mate. Boatswain Kelly lost the use of his arm but went on to serve in Korea and Vietnam, making the Navy a career, all because his adopted mother, Florence, and Lt Commander Robinson who saw something in this previously troubled young man.

President Anderson thanked Ted Robinson for a great program and presented him with a Liberty Bell and a Certificate of Appreciation. He announced the speaker of April would be Susan Gillespie, portraying Sarah Winchester.

After the guest speaker was finished President Anderson conducted the raffle. Those donating raffle gifts were: Alan and Susan Brooking, tom and Marilyn Chilton, Sandy and Craig Anderson, Jeff and Ursula Sylvan, Jim and Karen Faulkinbury, Ernie and Helen Garcia, Harlan and Sidney Ann Tougaw, Doug and Wilma Cross.

President Anderson thanked Don Spradling for taking pictures and maintaining the flags; Susan Brooking for selling the raffle tickets; Alan Brooking for chairing the Calling committee, acting as cashier, and conducting the raffle; and Neil Elvick for editing the newsletter.

A motion to adjourn was made and seconded. Tal Norwood led the Recessional and Jeff Goodwin gave the Benediction and led the Chapter in singing God Bless America. The meeting was adjourned at 9:18 PM.



The Battles of Lexington and Concord were the themes for this year's Americanism Elementary School Poster Contest. This contest is sponsored by the national society each year and is open to those elementary students in the grade that is studying the American Revolution, which in California is mostly 5th graders. The posters pictured below were from students in the four schools that participated this year in the chapter's contest. They were Green Valley Elementary, Sandra Gallardo Elementary, Oak Chan Elementary, and Isadora Cohen School. The posters are judged on such things as creativity, originality, historical accuracy and artistic merit and also on how well the poster exhibited the theme. Small cash prizes are awarded to students creating the five top posters in each classroom and the top overall winner's poster is entered in the statewide contest. Tom Chilton is the chairman of this program and was responsible for organizing this display. This program reaches approximately 500 families each year.

Patriot Biographies

Jim Faulkinbury reports that so far 11 of the biographies have been submitted to the national organization from the Sacramento Chapter. The Chapter will qualify for a Streamer if a total of 36 are submitted by June 1. To reiterate, there is no required format but it is requested that the information be limited to approximately 500 words and be submitted as a Microsoft Word document. Your patriot biography can be submitted to patriotbios@sar.org but also send a copy to either Craig Anderson (craig@winfirst.com or 916-257-7892) or Neil Elvick (neilel@aol.com or 916-730-6345) so we can present them here. Either of them would be happy to assist you with this if you wish.

The following two Patriot biographies were submitted by a descendant and Chapter member, Peter Hefler. The accounts were taken from an autobiographical account that was written down in John Arndt's family bible that has since been handed down to the oldest male descendant in each generation.

Jacob Arndt, the Patriot, was born in Baumholder [Germany] on March 24, 1725. Following the family's immigration to America, Jacob married Elizabeth Gieger and purchased a farm in Rockhill, Bucks Co., Pennsylvania. He worked there as a shoemaker following his father's trade. In 1755, with the French and Indian War, he accepted a commission as Captain in the Provincial service. His company was stationed on the frontier at Forts Norris and Allen to prevent Indian incursions. By the end of the War, he was a Major in command of Fort Augusta until the troops were disbanded and discharged from military service. He returned to Bucks Co. but soon purchased a new farm on Bushkill Creek near Easton in Northumberland Co., Pennsylvania in 1760. When the discontent with Great Britain commenced, he used much of his financial resources to support the patriot's cause. He was elected by the citizens of Northampton County to represent them in the first convention where he worked on the committee with Benjamin Franklin that framed the First Pennsylvania Constitution. He was a member of the Pennsylvania House Representatives and the Pennsylvania Executive Council. Jacob died on August 3rd, 1805.

John Arndt, the Patriot, son of Jacob and the author of the autobiography was born in Rockhill, Bucks Co., Pennsylvania on June 5th, 1748. He moved with his parents and siblings to the farm near Easton. He married first to Elizabeth Fiet of Sussex Co., New Jersey on December 13th, 1774. Elizabeth died in January 1776, shortly after the birth of her first child who had also died a couple of days earlier. Without a family he continued his occupation as a miller but the crisis with Great Britain quickly changed his occupation. He was asked by the county committee to take command of a company of riflemen for the Flying Camp. He was appointed Capt. In the First Battalion of Associators, part of the Flying Camp of ten thousand men commanded by Col. Hart. His company was ordered to Long Island. Capt. John Arndt's career was short lived. At the Battle of Long Island, he was hit in the left arm by a small cannon ball on Augusty 27th, 1776. The ball shattered his elbow and left him unable to use that arm. While in the hospital, being treated for his wound, the remaining members of his company were transferred to another officer. During the ensuing continuation of the battle many of the members of his company were killed. When he returned home, having recovered enough from his wounds, the parents of the lost members of his company brought charges of incompetence against him for their losses and he was put on trial. In his defense it was shown that he had been hospitalized and most of those killed were under the command of another officer while he was recovering from his wound. He was acquitted. In 1777, the new Pennsylvania government appointed him as Register for the probate of Wills and Recorder of Deeds for Northampton County. On April 5th, 1779 he was appointed to the Council of Exchange for Northampton County, and on October 20th, 1783 appointed to the Council of Censors representing Northampton County. Even though not responsible for the loss of his company at the Battle of Long Island, he declined ever applying for a pension from the state of Pennsylvania for his service. John married 2nd to Elizabeth Ihrie on August 12th, 1777 and had a family of ten children by this second marriage. In 1796 he moved from the farm near Easton to the town of Easton where he remained for the rest of his life. His oldest son, George, who received the Bible following John's death, followed the autobiography with the comment that John Arndt died on May 6th, 1814 at age 65.
