Chris Kinsey, PE

US Bureau of Reclamation

Central California Area Office Chris Kinsey works as a Project Engineer for the Bureau of Reclamation's office at Folsom Dam. In this capacity, Chris is involved with the management and coordination of the many ongoing projects of Folsom Dam and supporting facilities. Current projects include the Joint Federal Project (Folsom Dam Auxiliary Spillway), Mormon Island Auxiliary Dam Safety Improvements, and Folsom Main Dam Piers and Gates Improvements.



In 2011, Chris retired as a US Navy Commander after 31 years of active duty service. He spent 25 years as an officer in the Civil Engineering Corps. He is a graduate of the United States Naval Academy, Annapolis, MD. He earned his Master's Degree in Civil Engineering from Oregon State University and is a licensed Professional Engineer (Civil) in California.

Chris' presentation will be about the Folsom Dam, its projects and progress.

The cost of these upgrades will probably exceed \$500,000,000.00 and is probably the largest public works project in Sacramento's history. Bureau of Reclamation representative Chris Kinsey will be our speaker on Friday, February 17, at 7:00 PM, at the Buggy Whip Restaurant. He will describe these projects and give us an update on their progress.

January Meeting Minutes

January 20, 2012

President Don Littlefield called the meeting to order at 7:07 PM.

Jeff Goodwin gave the Invocation, Ron Carello led the membership in the Pledge of Allegiance, and John Vawter led the Pledge to the SAR.

President Littlefield recognized the past presidents of the Sacramento Chapter: Tom Chilton, four time past president, Jim Faulkinbury, who is also the CASSAR Vice President – North, and Jeff Goodwin who is also our CASSAR Chancellor.

DAR members recognized included Marilyn Chilton of the Sacramento Chapter, and Lee Lawson and Ann Taylor of the Sierra-Amador Chapter. 
