In addition to presenting medals to deserving ROTC, JROTC, and U. S. Naval Sea Cadets Corps, our chapter also supports the "Enhanced ROTC Program." This is a contest in which cadets submit an application describing their academic achievements, extra-circular activities, and JROTC accomplishments, along with a 500-word essay on how ROTC has affected their lives. This year's Sacramento Chapter winner was Cameron Hoover, a junior at Vanden High School in Fairfield. Not only was he the chapter winner – he won the CASSAR contest, and the NSSAR contest. Cameron and his mother will fly to Greenville, South Carolina, to attend the NSSAR Congress in July, where he will be recognized as the National winner. Congratulations, Cameron!!!
